## **ANNUAL NOTICE OF HEALTH CARE SERVICES ACCESSIBLE TO STUDENTS**

Pursuant to Ohio Rev. Code 3313.473(B)(4), below is a list of all health care services available to our students through the School District and in connection with outside providers. As a parent, you may withhold consent or decline care on behalf of your child for any of the physical, mental, or behavioral health care services listed below. Please note that withholding consent or declining access to services will ***not*** waive your right to access your child's educational or health care records.

School Nurse and Health Aides	Hearing Screening	State law <b>requires</b> the District to conduct hearing screenings on kindergarten students.	Private Provider or Community Health Center
School Nurse and Health Aides	Vision Screening	State law <b>requires</b> the District to conduct vision screenings on kindergarten students.	Private Provider or Community Health Center
District Speech-Language Pathologist	Speech/Language Screening	State law <b>requires</b> the District to conduct speech/language screenings on kindergarten students.	Private Provider or Community Health Center
School Nurse and Health Aides	Diabetes Care	State law <b>requires</b> BOE/District to provide appropriate diabetes care to enrolled students who have diabetes.	Private Provider or Community Health Center

School Nurse and Health Aides	General Health Care	State law <b>permits</b> the District to appoint a nurse but <b>does not require</b> BOE/District to appoint or contract health care providers	Private Provider or Community Health Center
School Counselor and Private Provider	Mental Health Counseling; Behavioral Support	State law <b>does not</b> require the District to provide this service.	Private Provider or Community Health Center
School Psychologist	Behavioral Support	State law <b>does not</b> require the District to provide this service.	Private Provider or Community Health Center
Private Provider	Drug and Alcohol Cessation Programming	State law <b>does not</b> require the District to provide this service.	Private providers, guidance counselor, school psychologist
Teachers, School Counselors, School Psychologists, School Nurse	IDEA- or 504-Plan Qualifying Disability Assessment/Evaluation	State law <b>requires</b> the District to provide these services.	Private providers
Private Provider	Community Health Supports/Referral	State law <b>does not</b> require the District to provide this service.	None
